These setups are to be in designated areas only. ABSOLUTELY no grooming allowed in the day-of-show parking lot. No mats or other devices that cover the grass may be used. Bathtubs will be available this year across from the grooming buildings.  
**GENERATORS** THERE IS NO POWER ON THE SHOW GROUNDS. BRING YOUR OWN GENERATOR.

No generators are allowed to be operated within 60' of any show ring after the start of judging and until all judging has been completed. Show sites are becoming more difficult to obtain as are accommodations that will accept dogs. The Kennel Club of Beverly Hills asks for your cooperation in cleaning up after yourselves and your dogs. **Entries** - Entries must be on the enclosed blank or on an official AKC entry form. Photocopies must include the Agreement. Entries not on an official AKC entry form are not acceptable. Owners are responsible for errors on entry blanks, whoever may make such errors.  
-Entry fees will not be refunded in event of errors or cancellation of entries after the published closing date, duplicate entries, nor in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by the Show Committee.  
-Returned checks do not constitute a valid entry fee.  
The show secretary will add a collection fee of \$25.00 to the amount of each returned check. The returned check must be made good by cash or money order before the dog will be allowed in the ring.  
-If, because of extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.  
-No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.  
-Entries must be on the enclosed blank or a reasonable facsimile thereof.

**Declination of Entries** - BCCGLA may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against BCCGLA or any official thereof.

**Move up to Best of Breed** – A dog which according to their owner's records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition provided this transfer is made by the Show Secretary at least one-half hour prior to the start of any regular conformation judging at the show.

**PUPPY SWEEPSTAKES**

Puppy sweepstakes is open to any Border Collie entered in one of the regular classes and whose age is no less than six (6) months and not yet eighteen (18) months on the day of the show. Champions of Record may be entered. No professional handlers.

*Dogs must also be entered in one of the regular conformation classes.*

The following classes will be provided for both dogs and bitches:

- Puppy, 6-9: at least 6 months but less than 9 months of age
- Puppy, 9-12: at least 9 months but less than 12 months of age
- Puppy, 12-18: at least 12 months but less than 18 months of age

**Judging and Awards**

Each age class will be judged to fourth place. Placements will be awarded a prize ribbon in addition to any stake as described below. First place in each class will be judged for Best in Sweepstakes and Runner-up to Best in Sweepstakes.

**Division of Stake:**

25% of total entry fees will be retained by the Club for expenses.

The remaining 75% will be divided as follows:

- First place in each class will receive \$6 per entry in that class.
- Best in Sweepstakes will receive 70% of \$5 (or \$3.50) times total entries in Sweepstakes
- Runner-up to Best in Sweepstakes will receive 30% of \$5 (or \$1.50) times total entries in Sweepstakes

## AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned, co-owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best Of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch. • If one of the Selects is eligible, excuse all champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible winner.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves*

### AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem to be sufficient. 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the event and of the opportunity to have the dog tested or judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its' members, directors, governors, officers, agents, superintendents or show secretary and owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I(we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in the event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are not confirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
